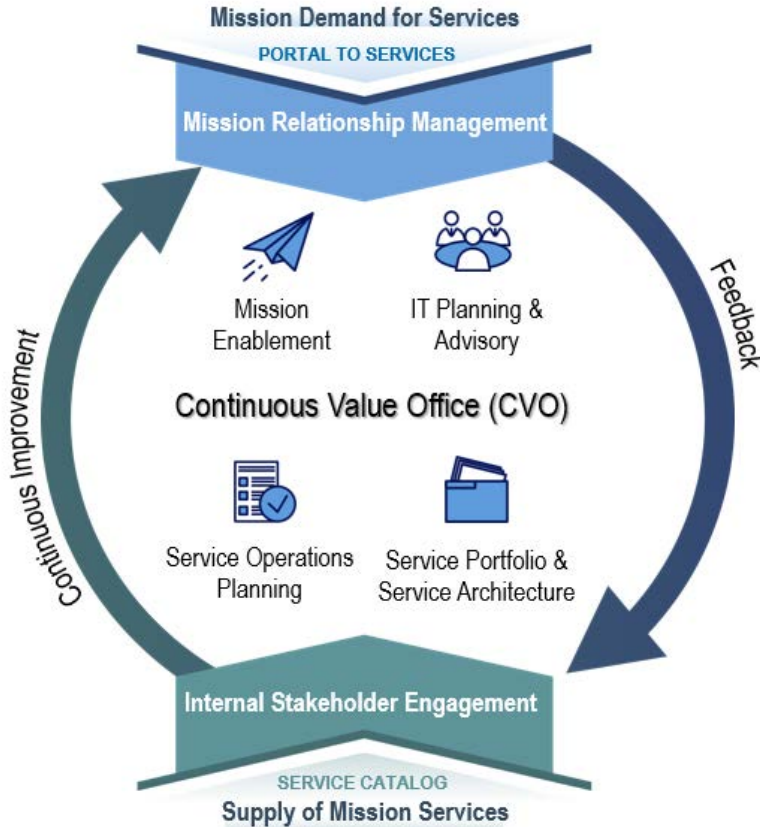

Business Architecture Defined

- ❑ Participating Stakeholders(s)



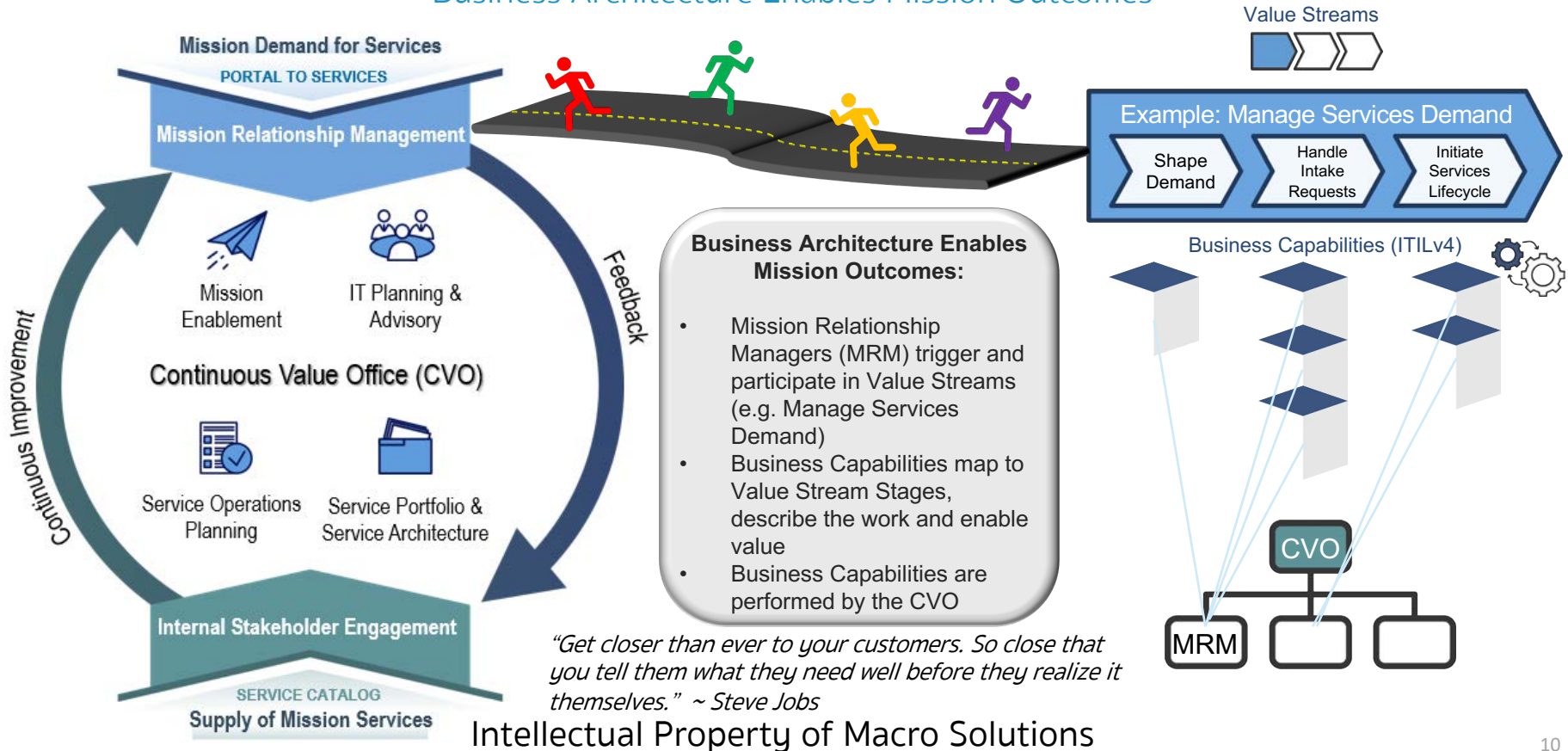
- ❑ Defines "What" work the organization does; not about "How"
- ❑ Reference models such as ITIL v4 Management Practices
- ❑ Enables Value Streams
- ❑ Identify redundancies, gaps, and pain points and supports heatmapping



- ❑ Represents the IT service organization, business units, and all stakeholders
- ❑ Helps to understanding redundancies and overlaps
- ❑ Foundational building block -- analyzing roles, skills, resources

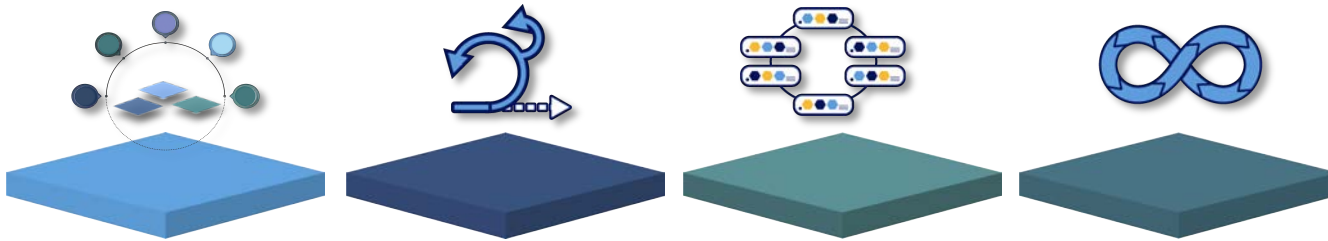

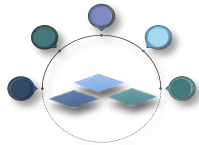
DevSecOps Services for Application Modernization

- Lesson Learned - Principles and Practices:
 - Evidence-based continuous improvement – metrics, tools, processes
 - Emphasis on Lean flow in the SDLC to help determine proper metrics to generate evidence
 - Automation for tools and technology and emphasis on reuse and scalability
 - Culture for people and emphasis on transparency and trust.
 - Managing business outcomes prioritized over business processes
 - Common Hurdles
 - Culture conflict between contract language and agile
 - Culture conflict between Lean/Agile approaches for DevOps and traditional Project Management
 - Test Automation skills in industry and investment appetite
